

Instructing a professional estate administration provider: What to consider



Following a bereavement, there are a number of tasks to be considered and completed. This responsibility falls to the Executor(s) if there's a Will or Administrator(s) if there is no Will (known as intestacy). Both roles have the same responsibility; to administer a person's legal and tax affairs when they have passed away. This process is known as estate administration which involves dealing with all their assets (such as property, shares and personal possessions), paying debts, paying any tax and transferring inheritance.

The role of Executor or Administrator can make an already difficult time even more stressful. This is often why the person responsible will turn to a professional, such as a Will Writer, Solicitor or professional estate administration provider, to help them finalise the affairs of a loved one or friend.

Things to consider when appointing a professional estate administration provider



Fees can sometimes be based on hourly rates or a percentage of the estate. These charging methods can mean the final bill total is unknown.

However, regulated firms are required to be transparent in regards to price. This includes informing you of what they are proposing to charge upfront.



Legal and financial responsibility

Generally, the legal and financial responsibility will remain with the Executor or Administrator. This is not always the case as some professionals will take the burden off vour shoulders.



Some professionals will complete all of the tasks involved in the estate administration process. Other professionals will only obtain the Grant of Probate (the legal document which confirms that the Executor has the authority to deal with the deceased person's assets). It's important to find out exactly what is included in the service and what is not.

Many professionals offer estate administration but when a complication arises, not all providers have the in-house capability to resolve the matters. Find out how the professional will handle your loved one's affairs.

If you're considering appointing a professional, it's important to understand exactly what service you'll receive and what price you'll pay. Make sure you ask these important questions:

- Will you just be obtaining the Grant of Probate or will you complete the full estate administration?
- (If pricing is based on hourly rate or % of the estate.) Are you regulated to provide probate services? Can you offer me a fixed price as I'd like to understand exactly what I'm paying?
- Is absolutely everything included in the price you've quoted? What is included in the price? And what is not?
- Do I still keep the legal and financial responsibility that comes with the role of an Executor/Administrator?
